# **Course Description:**

This English Language Arts course for tenth grade is devoted to an academic study of American literature from the colonial period to the twenty-first century. Because much of the early literature is nonfiction (diaries, letters, sermons, almanacs, speeches, and foundational documents), there are many opportunities to analyze historical and informational texts. Students come to see the fluid relationship between fiction and nonfiction: for instance, the literary tropes in Jonathan Edwards's "Sinners in the Hands of an Angry God," or the dual historical contexts of Arthur Miller's The Crucible. In seminars, students discuss questions such as "Does Anne Bradstreet's work typify or differ from the other Puritan literature that you have read. Throughout the semester, students have opportunities to make connections with history, art, and other subjects. Essays range from the analytical to the creative. Students will have the opportunity to write a narrative essay in the style of Thoreau's Walden or compare the treatment of a given theme in works from different genres. Students build on their writing skills from previous years, integrating multiple sources and perspectives into their work, reading literary criticism, and writing longer and more complex essays. To reflect the increasing importance of graphics and visual images in texts published in print and electronic media, students are asked to analyze how such images both relate to written texts and serve as alternative forms of text themselves. By the end of the semester, students have a foundation in American literature and are ready to branch out into other cultural representations of literature.

Students are expected to

- construct meaning from text by making connections from previous knowledge to new information.
- identify universal themes.
- evaluate how an author's diction, syntax, tone, and voice shape the intended meaning of the text, achieve specific effects, and support the author's purpose.
- apply effective strategies and techniques in their own writing.
- create and sustain arguments based on reading, research and/or personal experience.
- advance effectively through the stages of the writing process.

## **UNIT ONE - The New World**

- Identify emerging themes in early American literature, such as a "new Eden," "salvation," and "cooperation and conflict."
- Compare and contrast the experiences of America's earliest settlers, as conveyed through primary source documents and literature of the Colonial Period.
- Identify and explain elements of Puritan literature.
- Explain "preaching" as a type of formal speech and explain its role in the "First Great Awakening."
- Explain the role of religion in early American life.

# **UNIT TWO - A New Nation / Persuasion Politics**

- Identify universal themes in American literature and explain the historic and literary significance found in America's founding documents.
- Analyze how tone is established in persuasive and argumentative texts.
- Analyze the use of rhetorical elements in persuasive and argumentative texts.
- Compare and contrast points of view in arguments presented on related issues.
- Analyze how the qualities of effective persuasive techniques contribute to effective arguments.

# **UNIT THREE - American Romanticism / Transcendentalism**

- Define the major characteristics of American Romanticism (e.g., use of symbols, myth, and the fantastic; veneration of nature; celebration of the self; and isolationism).
- Compare and contrast transcendentalism and American Romanticism.
- Trace characterization techniques in American romantic selections.
- Analyze the structure and effectiveness of arguments in transcendental essays.
- Make connections between romantic literature and Puritan beliefs and values.

# **UNIT FOUR – Diversifying America**

- Determine and analyze the development of nineteenth century American literature (e.g., freedom, the American dream, racism, regionalism, and survival).
- Compare the treatment of related themes in different genres.
- Explain how fictional characters in late nineteenth-century America express the challenges facing America at the time, citing textual evidence from both fiction and nonfiction to substantiate claims.

# **UNIT FIVE - Emerging Modernism**

- Identify characteristics of modern texts.
- Analyze the relationship between themes in early twentieth-century American literature and nineteenth-century American thought.
- Define and explain the Harlem Renaissance.
- Explore the relationship between historical events and literature as they emerge in the works of Harlem Renaissance poets and authors.

- Encourage students to find examples of strong debates and create a rubric for what makes a strong debate. Share the rubric with all students, and point out these qualities during the debate.

# Struggling

- Encourage students to use ReadWriteThink's "Literary Graffiti Interactive" or other graphic organizers to help them visualize and comprehend what they are reading about.
- Pre-assess students for their knowledge about each unit and consider pre-teaching key ideas on the day prior (for example, giving them the handout of the lecture to read).
- Reteach students who have not obtained mastery of 70% or better.
